The, ST & SC Development Department, Government of Odisha has invited applications for **FRESH / RENEWAL** of **Odisha State Scholarship Portal (OSSP)** to ST/SC/OBC/SEBC/EBC (Economically Backward Class) for the year **2023-24**. Eligible students are advised to submit their Fresh applications through online mode by accessing web site **State Scholarship Portal**, link : **164.164.122.169:8090/https://scholarship.odisha.gov.in/website/home** and obtain a print-out of the fresh application form and submit it to the Cabin No. 9 (Ground Floor) **on or before 20.12.2023** and submit the hard copies of application along with the relevant documents / certificates **on or before 25.12.2023** without fail. Eligibility Criteria :-

1. All the eligible ST/SC/OBC/SEBC/EBC (Economically Backward Class) students should be permanent resident of Odisha.
2. The annual family income of the parent/guardians from all sources of those ST/SC students should not exceed Rs. 2,50,000/- per annum.
3. The annual family income of the parent/guardians from all sources in case of OBC/SEBC students should not exceed Rs. 2,50,000/- per annum and they have to secure at least 50% marks in previous examination.
4. The students should continue their Post Matriculation Studies in any general/technical or professional courses in any Govt. or Govt. recognized Private Institute.
5. The annual family income of the parent/guardians from all sources in case of EBC students should not exceed Rs. 100,000/- per annum and he/she should have to continue his/her higher study in Govt. institute only.
6. This scheme for EBC is applicable only for GENERAL category (Other than SC/ST/OBC/SEBC)
Eligibility Criteria for sanction of Odisha State Scholarship Portal (OSSP) in Financial Assistance Scheme
 - (i) The annual family income of the parent/guardians from all sources of those ST students should not exceed Rs. 2,50,000/- per annum.
 - (ii) He/She should be permanent resident of Odisha.
 - (iii) The students who have applied for Post Matric Scholarship under Financial Assistance Scheme. In first instance they will be sanctioned under Post Matric Scholarship Scheme and the excess amount not admissible under Post Matric Scholarship Scheme will be sanctioned out of Financial Assistance Scheme.

 - i). All educational certificates / mark sheets, ii) Income cert. iii) Caste Certificate, iv) Residential certificates , v) Aadhar card, vi) First Page of Bank Pass book (self Bank Account).
